#### Title: Scholarships for Disadvantaged Students

#### Objectives of the Practice:-

1. The scholarships aim to support the needy and poor students from different segments of society in Akole taluka.
2. The scholarships will enable these students to continue their education and complete their degree.

#### The Context:-

The college is located in hilly and rural area. The maximum number of students belongs to SC, ST, NT and OBC categories. Moreover the number of girl students is very high in the college. This is basically a disadvantaged class of the students because most of them come from socio-economically weaker section of society. In this context, the scholarships can help these students to complete their higher education.

#### The Practice:-

Most of the students of our college belong to SC, ST category and their financial condition is very poor. Most of the students took their education by working during the vacation period, that's why these students need financial help. So, the college tries to create awareness about the different kinds of scholarships for the disadvantaged students through prospectus, notice board and students counseling and orientation. The students made aware of different kinds of scholarships.

The facility for online submission of the scholarship form has been made available to the students by the college. We have made extra efforts to get in touch with the **Hindustan Petroleum Corporation Limited** authorities and convince them about our students' need for the scholarship. We persuaded them to grant scholarship to reserve category students.

We have also taken special effort to contact and convince the **FOC (Friends of Children) Pune** and they help our College fee and exam fee of poor meritorious students from 11 classes, until they get employment. They also help conducting courses for senior students, preparing them for recruitments through mock interview, group discussion, corporate etiquette

**SPPU, Pune** also grants different kinds of scholarships to talented students on the basis of their merit. We motivate the students to take benefit of these scholarships. All of these students were only able to finish their schooling because they were given grants. Without them, they would have dropped out.

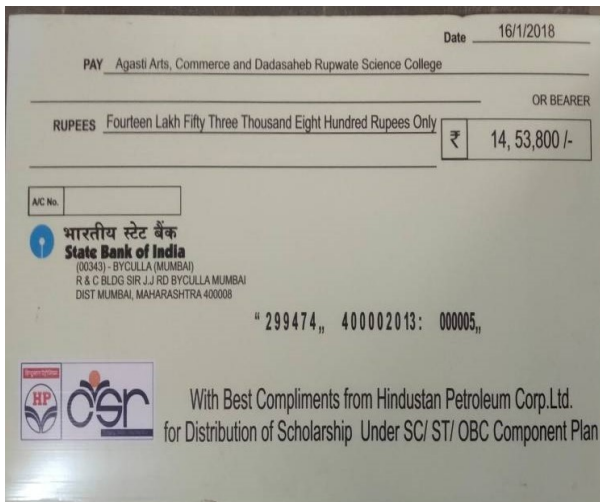
### Problems Encountered and Resources Required:-

### 03. Best practices in the Library

#### Title: Best practices in the Library

#### Objectives of the Practice:-

1. For simplifying the process of providing the books and journals to the students and staff.
2. Informing the students and staff about e-books and e-journals and making them available for their use.
3. Making the reprographic/Xerox facilities available to the students and staff.
4. Making the library services available to the stakeholders and increasing dialogue with them.
5. Using bar-coding software for updating library facilities.
6. To present rare and old books in the archives of the library and making them available to students and staff.

#### The Context:-

The library's operations are taking place within the greater social environment of rural and tribal communities. Most of the staff and students were not teacher friendly, but they did their best to generate literary awareness about the technology that was employed in the library and convince the teachers of the importance of the technology. The usage of software in the library has made it easier for both the students and the staff to search for books and journals, as well as to borrow those books and articles.

Information literacy program was organized by the library for the benefit of the students. Frequent interaction with students and staff not only raised their awareness of the availability of e-sources but also pushed them to make use of such sources in order to attain their academic goals.

#### The Practice:-

The following actions have been done by the library in order to make it user friendly and to ensure that all stakeholders are satisfied with the services provided by the library.

- Library housekeeping operations are automated using SOUL 2.0 library management software.
- Bar-coding of all books is produced by library staff only, not outsourced from any

vendor.

- The library maintains social media profiles (pages) on which it promotes its services and displays new materials that have been added.
- On the occasion of A.P.J.Abdul Kalam's birth anniversary, library has been organizing books fair every year.
- Orientation and information literacy programmes are conducted every year for newly admitted students and faculty members.
- The library staff goes through the ID cards made by vendors to make a record of users.
- On the occasions of annual social function of college, books exhibition is arranged by library.
- For digital resource management, library is using D-Space (Repository Software) in which old question papers, Ph.D thesis of faculty members, Research students were kept.
- Library has archival collection of old text books.
- Library is providing newspapers clipping service to all users.
- Library is providing display service for events/ news/ function/ photographs/ instructions on big TV display for users.
- The staff is free to recommend and purchase reference books and new books required by their department.

### Evidence of Success:-

The library has been successful in achieving the targets and benchmarks. The result of the best practices is that the number of students using library facilities has gone up. There is greater awareness about the latest e-sources of learning. The process of issuing the books has become easier for library staff. The new arrivals are displayed and this motivates them to use these books for updating their knowledge. There is greater interaction between library and stakeholders.

The steps taken by library have affected the books of students study and now some of them feel confident enough to express themselves through writing articles in college magazines. The use of bar-coding and software has made it easy to find the relevant books and this has helped to minimize the manpower.

Most of the teachers and non-teaching staff was not quote techno-friendly in the beginning, but we took approximate steps to sensitize them about the library using technology through various awareness programs.

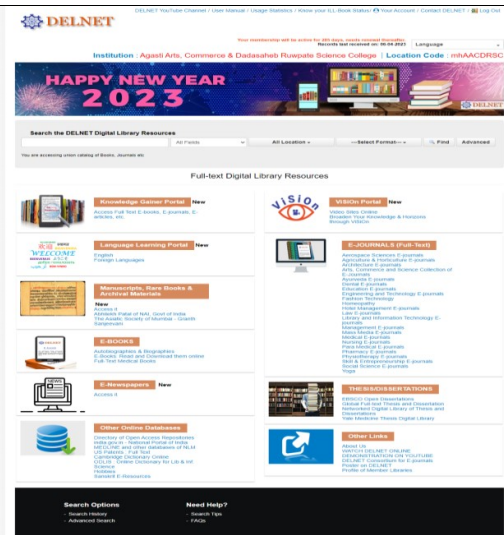
The renovation of the library's facilities was not without its share of financial challenges. We presented our case to management, and management was willing to shoulder a portion of the financial load.



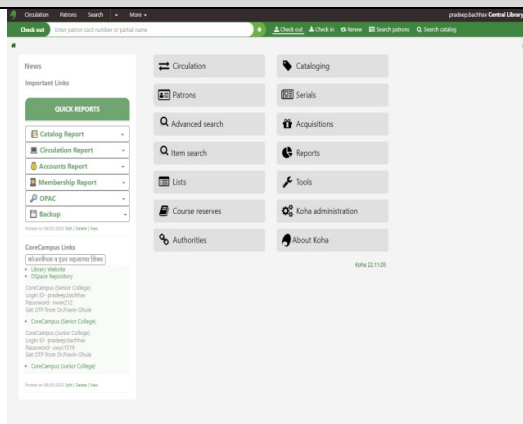

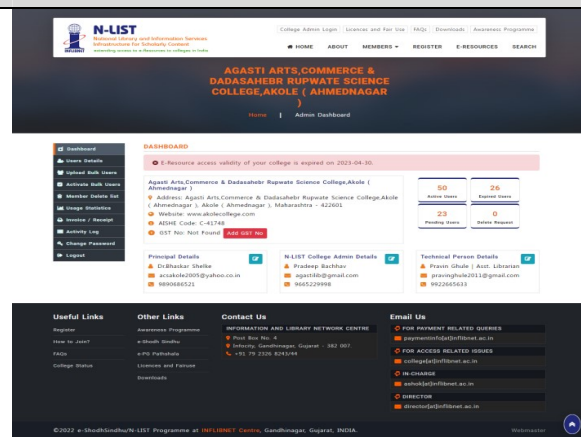

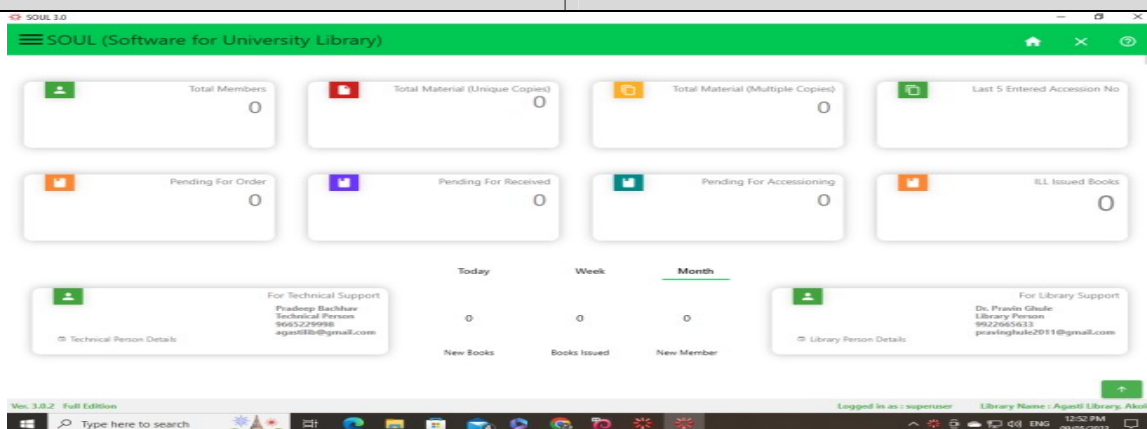

### **04. Higher Education for deprived student through YCMOU**

#### **Title :- Higher Education for deprived student through YCMOU**

##### **Objectives:**

The YCMOU helps students who did not pass the HSC or who dropped out of high school. Giving everyone the chance to get an education, even those who drop out of high school and don't pass the HSC test. Giving schooling to girls who couldn't go to college because they got married young. Giving schooling to people who had to start working at a young age is hard because they have to take care of their families and have limited money. Giving people who are already working the chance to get a graduate degree so they can learn more and improve their skills. To make YCMOU students more aware of social issues through NSS programs while they are getting their higher education.

##### **The Context:**

The college is located in rural and tribal areas. It meets the needs of children from SC, ST, NT, and OBC (other backward class) groups. There are also a lot of girls in school. Many of them, however, were not able to finish college because of bad social traits and conservative family values. They got married young, so they can't go to college like everyone else. In rural places, there are still a lot of people who drop out of high school. Students in this situation can finish their higher education at YCMOU.

Notwithstanding the fact that they had a gap in their schooling, they planned to complete their SSC, HSC, and D.Ed degrees and then apply for any job that was open. They want to advance their education to the level of a degree, and YCMOU provides them with the opportunity to do so. The procedure: In practice, the college makes an effort to raise students' consciousness about the possibility of obtaining an education through a distant learning system by disseminating information regarding this option via notice boards, student counseling, and prospectuses.

##### **The Practice -**

Those students who did not earn a passing grade on the HSC exam have the opportunity to participate in a remedial education program. After successfully completing the preparation course, candidates become eligible to receive a degree from YCMOU. Students enrolled in preparation courses are provided with lectures on a variety of topics for their benefit, and later on, they are required to do well on an examination based on the material covered in the course.

Those who have already finished their HSC can directly apply for degree courses at YCMOU such as B.A. and B.Com. In the B.A. Department, our institute offers specializations in Marathi, Hindi, English, Political Science, and History. Accountancy, Cost Accounting and Taxation, Banking and Finance, and Marketing Management are just few of the subjects that can be studied at our study center as part of the Bachelor of Commerce program.

For the benefit of all of these students, knowledgeable lecturers taught classes on Sundays and holidays. In addition to this, YCMOU supplies them with study material that is beneficial to them in the process of preparing for the final examination. Co-curricular activities, such as regular NSS activities and NSS winter camps, are put on for the purpose of fostering a sense of social responsibility among the student body.

The Success of Lokshahi Pandharwada is in the awareness of tribal area people. The students register the name in the electoral list. People vote freely and fairly.

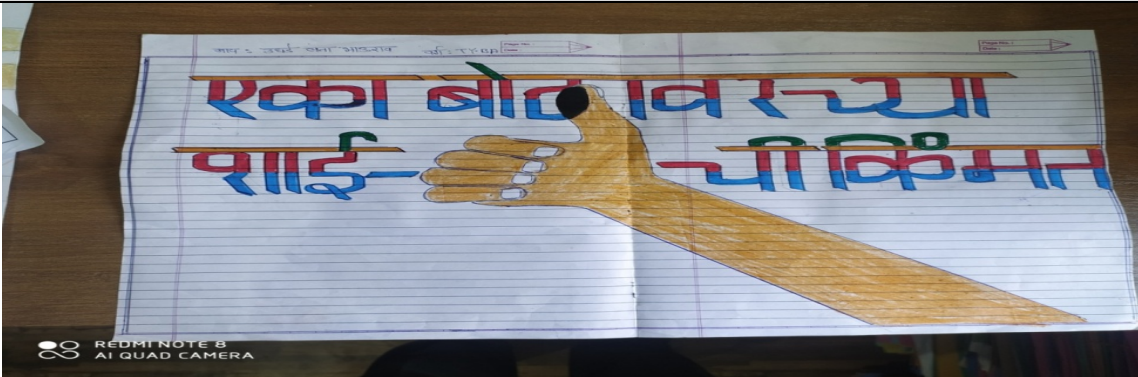
### **Problems Encountered and Resources Required**

Additionally, the announcement has been tacked up on the bulletin board. The lecturers also offer direction and advice to the students. The education of married girl students is fraught with numerous challenges; as a result, many of them have given up on their education or, in some cases, have been forced to leave the educational system altogether after being married. The truth of the matter is well acknowledged in agriculturally dominant rural and tribal communities. During the pandemic, which is known as Covid-19, it is being closely monitored. During this time period, a significant number of young women have entered marriage and consequently stopped furthering their studies. Because of this, the college has taken the initiative to ensure that married female students are able to continue their education. In order to do this, the "Savitri-Jyoti Abhiyan" was established in the years 2020-2021 during the pandemic known as Covid-19.

- The problems of these students have been understood and solved in a due course.




#### **Context –**

Everyone goes through difficult times and experiences in their life. On the other hand, the difficulties of life might have a much more profound impact and crop up more frequently for a disabled person who receives assistance from the NDIS. The World Health Organization (WHO) defines barriers as "factors in a person's environment that, through their absence or presence, limit functioning and create disability." When this occurs, problems have the potential to become obstacles.

It's not always easy to see the obstacles that persons with disabilities face, especially to those who are able-bodied. Onside Support Coordinators are familiar with the difficulties and can assist you in overcoming any obstacles that may arise while working with you. You should try to persuade them to take part in the extracurricular activities that are offered at their school. At home, you can help children hone their skills by playing often played games with them and giving them practice.

Play out scenarios like introducing yourself to a new person or giving a speech in front of an audience. Give them the assistance they need to construct a social and emotional support system consisting of friends.

People have a tendency to look at people with impairments and see pictures of people seated in wheelchairs, people who are blind or deaf, people with mental abnormalities, or people with autism. A limitation, on the other hand, is a more complex and obvious form of physical impairment. It's possible that one child with the same diagnosis will have a milder form of the condition than another. (A disability is defined as an impairment, which according to The Disability Act (2006), can be either sensory, neurological, or physical.) A person with a disability may have a diminished capability and capacity for self-care, management, communication, or mobility as a result of impairment such as this.

Students who have disabilities can also be understood in the context of the Disability Act's definition, which can be found here. Despite the relative ease with which it is described, children with disabilities not only experience some difficulties but also contribute to the disruption that occurs in the classroom. Students go through the anguish of growing up and living with their impairment, are treated differently in college and society in general, and invite various responses from their families. In other words, they are subjected to the suffering. Some of the pupils' family doesn't even care about them anymore, while other people give them their undying devotion. To begin, it is essential to have an awareness of the circumstances and the experiences that these pupils are forced to go through.

### **Evidence of Success:**

The handicapped students were able to draw rangoli with the help of this practice. The younger generation needs to learn that just because they have a disability does not imply that they are unable to receive good grades, go to college, or get the career of their dreams since they are able to do all of those things. The presence of a disability may bring about certain restrictions, but doesn't that go for everything? It all depends on how you choose to see past them and recognize your own strengths. It's possible that a person's progress will be hampered by misconceptions, prejudices, and the attitudes and beliefs of other people, but this does not indicate that disabled individuals are incapable of succeeding in their endeavors. Accepting the means by which we achieve our objectives is of the utmost importance; although we may require adaptations, this is not a reason for shame.

The educational system does not accommodate all students. The integration of students with disabilities ranging from mild to moderate into traditional college settings has proven to be a difficult task. There are several problems to be solved, such as ensuring impaired students have access to special education classes, colleges, and teachers who are properly qualified to work with disabled students. In addition, several higher educational institutions have failed to honor the reservations made for students with disabilities at those institutions. A significant number of disabilities, such as those caused by medical complications during birth, illnesses affecting the mother, a lack of nutrition, as well as those caused by accidents and injuries are able to be avoided. However, the health sector, particularly in rural India, has not been aggressive in its response to the issue of disability. In addition, there is a shortage of cheap access to appropriate medical care, as well as assistance and appliances.
